

Amendment to Service Agreement

This amendment to service agreement (“Amendment”) is made and entered into as of November 1, 2012 by and between Cayuga Medical Center at Ithaca, a New York not-for-profit corporation, (“Medical Center”) with its principal office at 101 Dates Drive, Ithaca, New York 14850 and Homer Central School at 80 South West Road, Homer, New York 13077.

Whereas, Medical Center and Homer Central Schools have previously entered into a service agreement as of August 1, 2012 whereby Cayuga Medical Center provides athletic training services

Whereas, Homer Central School would like Medical Center to provide additional hours for athletic training services

Whereas, the parties desire to amend the original agreement to include additional hours for athletic training services

The Medical Center will provide the School District with a part time NATA Certified Athletic Trainer to work 9.75 hrs per week from November to June in order to meet the School District’s needs outlined below:

Amended Services:

- a. Provide training room hours from 2:15pm to 5:00pm Monday, Wednesday, Thursday and Friday
- b. Provide training room hours from 11:30am-1:30pm Tuesdays
- c. The Athletic Trainer, the School District’s health staff and coaches will continually correspond regarding student athletes in need of and receiving athletic training services; care for the student athletes at Homer Central School is a priority for the Athletic Trainer; for those instances when there are no students or student athletes in need of athletic training services as communicated among the parties listed above, the Athletic Trainer will be made accessible to the Medical Center for coverage needs in other areas of the Sports Medicine department

Payment of Services: For the services rendered under this agreement, School District shall pay to the Medical Center \$9,146 in 7 equal monthly installments of \$1,306 commencing November 2012. The Medical Center shall forward a monthly invoice to School District for the services provided the prior month. The School District shall make all payments due to Medical Center within thirty (30) days following the receipt of an invoice. Questions regarding an invoice may be directed to the Accounting Office (607-274-4343).

Term: This Amendment shall commence on November 1, 2012 and end on June 30, 2013. This

amendment to the original agreement will be automatically renewed for subsequent terms of August 1- June 30, unless either party gives notice of intent not to renew by July 1 of the then current year.

All other services and terms will remain the same as those stated in the original agreement.
