Please note that pursuant to Education Law section 2857(1) and 8 NYCRR 119.4 (available at <http://www.p12.nysed.gov/psc/publichearing.html>), the school district of location is required to hold a public hearing to solicit comments from the community relating to the foregoing application. In addition, Homer Central School District has the right to comment directly to the Board of Regents on the programmatic and fiscal impact of the proposed charter school(s) on traditional public and non-public schools in your district.
