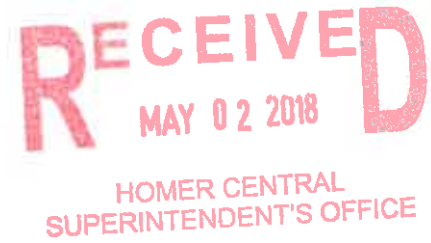
If the date should change I would notify you well in advance prior to the school year end.
